Financial Report

Sue Ellspermann reported to the Board as to the financial matters for Mid-States.

Sue Ellspermann further reported that the Dentons Bingham Greenebaum invoices and the related accounting of those invoices for the last period had been paid. Ms. Ellspermann provided further detail of the financial reports, including that the beginning balance for the period was \$333,516.99, and that the ending balance for the period was \$326,403.64.

Ms. Ellspermann also confirmed that each of the Board members had received in their packet additional financial information for the Fourth Quarter of 2022 and summary for the fiscal years of 2018 through 2022.

Ms. Ellspermann asked Chairman Schroeder to speak further regarding the financial report.

Chairman Schroeder commented on the summary fiscal information for the years 2018 through 2022. Chairman Schroeder noted that the accumulative receipts by Mid-States was \$7,348,727.07, and that the total expenses were \$7,022,320 to date. Chairman Schroeder noted that all public funds received had been distributed in payment of the Tier I EIS Study, and that the remaining funds were attributable to private donations received.

After discussion and upon motion made by Ken Mulzer, and seconded by David Drake, the following resolution was introduced:

Chairman Schroeder reported that Lochmueller is completing the final draft of the EIS. INDOT is currently reviewing all comments it has received, and Lochmueller is preparing responses to those comments, which are subject to review and approval by INDOT. After approval by INDOT, the Federal Highway Department will also review the comments and responses. It is expected that the ROD will be reviewed in March, which review will first be completed by INDOT and then by the Federal Highway Department.

Following these actions, Chairman Schroeder reported that U.S. Fish and Wildlife will be reviewing, and its review of the proposed ROD is expected to be completed by June of 2023.

Following a review by all agencies, the last action would be the publication in the Federal Register.

After discussion and upon motion made by Sue Ellspermann, and seconded by David Drake, the following resolution was introduced:
