Call to Order

Financial Report

Chairman Schroeder then confirmed that the members of the Board had previously received a report of receipts and disbursements for the 1st quarter of 2022 which he then further reviewed with the Board.

Chairman Schroeder further reported that the Dentons Bingham Greenebaum invoice was paid, and that there still is pending an additional invoice from Dentons Bingham Greenebaum.

LWG completed its final audit and that audit was recently received by Mid-States. Chairman Schroeder noted it was a clean audit and there were no issues identified by the outside auditors, LWG.

Payment of INDOT 2nd Quarter Invoice

Chairman Schroeder then noted that in connection with the prior negotiations with INDOT and as part of the supporting contractual relationship between Mid-States and INDOT, Mid-States had negotiated its final payment in connection with the funding of the Tier I Study. Chairman Schroeder confirmed that the previously negotiated final payment for \$1,040,400 had been pending with INDOT for several quarters. Chairman Schroeder confirmed that the invoice and payment had been completed and that the final payment had been processed by INDOT. Chairman Schroeder noted that there would be no further invoices from INDOT with respect to the Tier I Study. Chairman Schroeder then inquired if there were any additional questions from the Board of Directors regarding the financial arrangements with INDOT. The Board then discussed the financial arrangements with INDOT.

Tier I Study Update

Chairman Schroeder updated the Board that the Lochmueller Group was continuing its' work to complete the documentation for the Tier I Study. Lochmueller Group is reviewing all comments received in connection with the public hearings and otherwise from all interested parties which had been received through the comment period. Chairman Schroeder noted that the comment period had previously been extended in order to accommodate additional opportunities for the public to comment. Chairman Schroeder stated he understood that Lochmueller Group would continue their work and that a final Tier I report would be provided to Mid-States and to the public in the first quarter of 2023 .

Chairman Schroeder then asked the Board of Directors if there were any questions regarding the status of the Mid-States Tier I Study. The Board then discussed the current status of the Tier I Study.

AGREEMENT TO APPOINT THE BOARD OF THE DEVELOPMENT AUTHORITY

WHEREAS, the fiscal bodies of Dubois and Spencer counties (collectively, the "Counties") have each adopted an ordinance to establish a Mid-States Corridor Regional Development Authority (the "Development Authority") pursuant to IC 36-7.6 et seq., as amended (the "Act"); and

WHEREAS, the cities of Jasper and Huntingburg (collectively, the "Cities"), have also each adopted an ordinance to establish the Development Authority pursuant to the Act; and

WHEREAS, the Development Authority shall be governed by five (5) individuals (the "Board") who meet the criteria as defined under the Act; and

WHEREAS, the executives of the Cities and Counties (collectively, the "Members") must appoint the Board of the Development Authority by written agreement (the "Agreement");

Now, therefore, as the executives of the Members of the Development Authority, we agree to appoint the following individuals to the Board of the Development Authority, all of whom meet the criteria, as defined under the Act:

- 1. Mark Schroeder
- 2. Scott Blazey
- 3. David Drake
- 4. Sue Ellspermann
- Ken Mulzer Jr.

This Agreement To Appoint the Board of the Development Authority may be executed in counterparts, each of which shall be deemed to be an original, but all of which, taken together, shall constitute one and the same Agreement.

Effective the 31st day of March, 2022.
